LEARNING OUTCOMES

Health, safety, and hygiene for aesthetic procedures – learners will be able to apply their knowledge and understanding of implementing the essential health, safety and hygiene measures when preparing for and throughout delivery of the aesthetic procedures.

Client consultation for aesthetic procedures – underpins the practical technical units within the qualification/s. Learners will be able to conduct a concise consultation to determine and/or adapt the required procedure/s to meet the client's needs and achieve the desired outcome/s.

Skin rejuvenation using laser, light and energy-based devices – learners will be able to use a laser, light and aesthetic energy based devices to rejuvenate the skin and reduce or remove skin imperfections and mild pigmentary conditions.

Hair reduction using laser, light and energy-based devices – learners will be able to use a laser, intense light sources and aesthetic energy-based devices for hair growth reduction.

DRESS CODE

When performing laser treatments as a therapist, you should wear clean, professional clothing, preferably a uniform, and protective eyewear. Loose clothing is recommended to minimise friction, and jewellery and other items that could cause reflections should be avoided.

Clean Uniform:

A professional uniform is essential for maintaining hygiene and creating a positive image, according to the training school's requirements in line with their policies and procedures.

Protective Eyewear:

Laser safety glasses or goggles are crucial to protect your eyes from potential laser exposure. The specific type of eyewear should be chosen based on the laser's classification and the treatment area; this will be provided by the training school.

Loose Clothing:

Loose-fitting clothing on the body areas to be treated can help prevent friction and potential irritation.

No Jewellery or Reflective Items:

Jewellery, hairpins, and other items that could reflect the laser beam should be avoided to prevent accidental exposure.





BEHAVIOUR

Your behaviour, body language and tone of voice are to conform to a positive and professional student manner. The training school has a ZERO tolerance to abuse of any kind.

Recommended Behaviour:

- All bags, outerwear, phones, and personal belongings should be stored in provided lockers/storage areas, unless otherwise arranged with the tutor
- Water is the only drink permitted in sessions
- No other food or drinks are permitted

N.B. We can at times permit a learner to use their phone in the session to take before and after pictures, learners must always maintain a sterile field. Phones should be cleaned when they are brought into the session, gloves are applied after the before pictures and removed before the after pictures.
